TERMS AND CONDITIONS		
1. The Contract shall be deemed to	have commend	ced on and shall
continue and remain in force for	r a period of _	years unless and until
terminated in writing.		

2.	The Transporter agreed to provide bus in good condition
	properly registered with The Transporter agreed to
	take insurance coverage of the bus, Driver, third parties as well as
	occupants. In case if the Transporter fails to do so, the Transporter will be
	responsible for cost and consequence. If the Company is required to pay
	any money on account of failure of the Transporter to take adequate
	insurance coverage, the Transporter will reimburse all such cost, damages
	without any reservation to the Company.
3.	The Transporter agrees to deposit with the Company a Security Deposit of
	Rs ( Rupees only) prior to the
	commencement of the Agreement and it shall be refundable on the
	termination of earlier determination of this Agreement.
4.	The Company will pay to the Transporter an amount of Rs/-
	per month/per trip for hiring the bus along with driver for 26/27 days in
	a month. The said amount will be forK.ms and hours per
	day use basis. In case the K.ms are beyond in a month, the
	Company will pay to the Transporter Rs/- per K.m. beyond
	k.m. per month. In case the bus is used for beyond hours a day, the
	Transporter will be paid Rs/- per hour beyond hours. However,
	hours will not include the time lost on account of break down or
	stoppage of bus for reasons due to Transporter.
5.	The Transporter will operate the vehicle on all working days. In case if
	the bus is not available due to any problems, the Transporter will make
	alternate arrangement.
6.	It is agreed by and between the parties that in case of break downs, the
	Company will reduce payment to the Transporter by the distance not
	covered by the Transporter from the payment of the Transporter

7. The Transporter will operate the bus with driver having proper license,

and experience to the run the bus. The driver will be paid by the

Transporter and he will be under the supervision of Transporter.

8. The payment of salary of the Driver, fuel, Tax, Insurance, Maintenance

and repairs of the vehicle etc. shall be the responsibility of the Contractor,

which shall be discharged by him on regular basis.

9. The Transporter will submit the monthly bill at the beginning of the next

month, which will be paid by the company in full within 7 days of the

presentation of the bill.

10. The bus provided by the Transporter will be painted to the colour scheme

as suggested by the Company. For this, the Company will inform the

Transporter well in advance regarding the same.

11. In case there is any dispute, the same would be under Pune Jurisdiction.

12. This contract can be terminated by either of the Parties without assigning

any reason but by giving to another party a Notice of one calendar month.

13. The Company reserves the right to terminate the Contract in case of

failure to fulfill the said terms and conditions of the contract.
